07. Update on work and Presentation by the Park Keepers

The Park keeper informed the committee that he and the deputy park keeper were catching up on work in the open spaces following annual leave and bad weather. The hanging baskets were due to be collected the next day.

08. Omega reports: Review of performance to date, budget/expenditure/income

The Clerk had provided an Omega report to members prior to the meeting. Cllr Broughton asked if there were any questions on the reports but there were none.

09. Update on the electricity box on the John Eve Field

Cllr Broughton advised the committee that he had spoken to various electricians who were too busy to take on the work. Members agreed that as new electrical regulations have been introduced it would be best to produce a schedule of works, and then to obtain 3 quotes to select the best provider.

10. For members to consider the purchase of a promenade planter at £398.50 plus VAT It was proposed by Cllr Mrs Sked, seconded by Cllr Brookes and RESOLVED that the planter could be purchased to be placed next to the seat outside the rectory paddock.

11. For members to recommend to Full Council the payment of approximately £4000 for a reconditioned side arm flail mower

The park keepers confirmed that should this item be purchased, it could be stored in the park keepers' shed. It was proposed by Cllr Broughton, seconded by Cllr Miss Collins and **RESOLVED** unanimously that the purchase be recommended to Full Council.

There being no other business the Chairman thanked all for attending and the meeting was closed at 7.19pm. Members agreed that as the Amenities and Open Spaces Committee meetings are generally completed within half an hour, then they would recommend to Full Council that the following Town Hall and Cemetery Committee meetings take place at a regular time of 7.30pm as opposed to 8pm.
