Minutes of a meeting of Market Deeping Town Council's Planning and Highways Committee held on Wednesday 3rd April 2019 at 7pm in the Town Hall, Market Deeping. Cllr Shelton presided over Cllr Miss Moran and Cllr Gamble. The Deputy Clerk was also in attendance.

159 Chairman's Welcome

Cllr Shelton welcomed everyone to the meeting.

160 Apologies for Absences

There were apologies for absence from the Chairman Cllr Adam Brookes and Cllr Chris Davies.

161 To receive declarations of interest under the Localism Act 2011

There were no Declarations of Interest.

162 Minutes from the meeting dated Wednesday 6th March 2019.

Cllr Shelton asked the committee if they were to accept the minutes of the meeting dated Wednesday 6th March 2019. It was proposed by Cllr Shelton, seconded by Cllr Moran and **RESOLVED** unanimously that the minutes could be signed as a true and accurate record of the meeting. The minutes were signed accordingly.

163 Clerk's report on matters arising.

Members had received a report prior to the meeting.

130	Correspondence has been received from Persimmons Legal Department regarding
	clarification of the roads to be adopted on the new estate. They have informed us that
	technical details in relation to the roads are continuing to be negotiated with the LCC, but
	they are hopeful that these matters can be resolved quickly and that work on progressing the legal agreement will commence shortly.
130	With regards to the extension of the Conservation Area and the possibility of Market
130	Deeping being covered by an Article 4 Directive, the meeting between Cllr Redshaw and
	the Conservation Officer was rearranged from the 14 th March to 28 th March. Cllr Redshaw
	has agreed to report back to this Committee in due course. The Clerks have now received
	the report from Cllr Redshaw and circulated it amongst the Committee members present.
143	No further correspondence has been received regarding measures to prevent
	unauthorised access to Cross Road. The temporary closure which covered the period up to
	20 th March has now expired, although the barriers remain in place. A proposal for
	stopping up Cross Road permanently is currently being considered as a way forward by
	Lincolnshire County Council, but there is nothing further to report at this time.
155	With regard to investigate the feasibility of a residents parking scheme along Stamford
	Road/ Church St/High St, the Clerk has contacted a Councillor of LCC for advice and
	assistance in this matter.
156	A Planning Officer from SKDC has advised the Clerks that he has written to the owners of
	The Square eating establishment in the Market Place and informed them that they need to
	apply for retrospective planning permission for the choice of colour of the paint work, and

that the Town Council will be consulted.
Following enquiries and comments received from members of the public regarding the
condition of the town roundabout the Clerks have been in touch with the sponsors, Swines
Meadow Farm Nursery. They informed the Clerks that although they were due to do some
work on it in the near future they were happy to relinquish sponsorship at this time. The
Clerks thanked them for the work they had undertaken over the years. Enquiries have
been made by other businesses for the opportunity to sponsor the roundabout so these
will be followed up.

164 At 7.20pm a member of the public, a resident of The Nightingales, entered the meeting and requested to speak. Cllr Shelton informed them that the public session had closed but proposed that the meeting return to the public session to enable the member of the public to speak. This was seconded by Cllr Gamble. Issues raised by the resident were relating to noise, possible unauthorised building work and inappropriate choice of hedging. The Committee referred the member of the public to South Kesteven District Council as the relevant Council body to enact an appropriate course of action. The member of the public left the meeting at 7.30pm and the Council meeting resumed.

This is shown alongside an unshaded strip described as a 1.5m cycleway. It is unclear what the intentions are here. The Town Council wishes to seek clarification and be provided with greater detail. Rather than a 1.5m cycleway, the Town Council consider that the existing route of the

footpath should be upgraded to allow cycling and walking. Regardless, 1.5m is not adequate width for any cycle route. Whilst the location of the Drainage Board's dyke is likely to be a consideration, it is difficult to believe this presents an insurmountable barrier to upgrading the footpath on its definite line. Should it be impossible then the developer should seek a diversion to enable suitable provision for walking and cycling. It is also unclear how this 1.5m cycleway would connect to the adjacent proposed development. The Town Council also are disappointed that the grass-verge separation between the carriageway and footway on Burchnall Close isn't continued into the new development at least as far as the junction within the site for consistency.

The design of the litter bins shown is unlikely to be adequate. Bins of this design were installed on the nearby Market Deepings Persimmon development but later replaced due to their size. It would be desirable to adopt the standard South Kesteven District Council bin design that is larger and provides consistency with the style elsewhere.

With reference to changes to the access including the addition of a deceleration lane and movement of the pedestrian crossing to the roundabout, The Council has the following comments:

The northbound lane is quite wide as it comes off the roundabout. This will make it more difficult for the pedestrians to cross than at the location previously shown in the plans. Could this island be enlarged or hatching added to try to reduce the size of the lane and so make it easier to cross? A planning condition will need to be put in place to ensure that the off-site changes, including those mentioned above and the installation of the dropped kerbs etc are either carried

	out by the developer or funded by them.

Of particular interest was the comments made regarding the preservation of the Car Dyke and the need to ensure that in any future development houses are positioned facing the Car Dyke so as to ensure that it does not get obscured by fences and gardens and access is maintained. The Committee agreed that this was an important consideration and resolved to ensure that this would be the case in all future relevant applications. Also noted was the need to ensure that within the Conservation Area shop signage is maintained at first storey level only and members discussed the inclusion of a signs and advertising design standards within the Neighbourhood Plan.

There being no other business, Cllr Shelton thanked the members for attending and the meeting closed at 8.05pm. The next meeting was scheduled for Wednesday 1st May 2019 at 7pm.
