126. For members to discuss the proposed affordable housing developments on Wellington Way and Burnside Avenue and to decide on the next steps (Cllr Brookes)

Cllr Brookes reported on the 'Growth overview and scrutiny committee' meeting of 13 December 2017. He explained the plans for new social housing in this area; the houses, although allowing limited subsidies, will not directly be social housing, however profit from the sales would be used for social housing. Members were concerned that this protracted process would delay the provision of true affordable housing in Market Deeping. Members discussed the potential demolition of the old cookhouse, now the Scout Hut, despite their request to have it registered as an 'asset of community value'. Members also discussed potential footpath links between the Larkfleet development and this area. It was agreed to keep this item on the agenda for the next meeting to allow all members to consider the matter further.

Highways

127. Conservation Area: for members to review any matters in the area, to include the consideration of suitable replacement signage on the roundabout.

The 'Streets for all' website recommended by Ian Wright, conservation officer, did not provide sufficient examples of suitable signs so members will continue to look. Cllrs asked the deputy clerk to write to SKDC asking who would be responsible for any new 'keep left' signs on the roundabout, and who would pay for the installation.

128. For members to receive the local profile for the SKDC local plan and recommend its approval by Council (Cllr Shelton)

Cllr Shelton advised that a draft profile produced by the Neighbourhood plan will be available to members by Monday for approval at the next Full Council meeting.

129. For members to receive an update on footpath 4

The council has received a letter from the Planning Inspectorate confirming that the council is indeed a local authority for the purposes of the Highways Act 1980, Sections 118 and 26, and that a Local Inquiry will therefore be required. They will provide a time period in which the inquiry can take place.

130. Update on the Community Speedwatch program and the purchase of Wheelie Bin Stickers

The deputy clerk advised that the post of CSW coordinator will be filled imminently and Cllrs Gamble and Miss Moran could then be registered for training on operating hand held speed cameras. Cllrs agreed that the purchase of wheelie bin stickers, at a cost of 50p per sticker, would be advantageous, and it was agreed that Cllr Shelton would raise the matter at the next Full Council meeting on 10th January.

131. To update members on the information from the interactive Speed Sign (Cllr Brookes)

There is no update at present.

There being no further business, the meeting closed at 8.15pm. The next meeting was scheduled for Wednesday 7th February 2018 at 7.00pm
