Market Deeping Town Council - Planning and Highways Committee

Minutes of a meeting of Market Deeping Town Council's Planning and Highways Committee held on Wednesday 4th January 2017 at 7.30pm in the Town Hall, Market Deeping. Chairman Cllr Shelton presided over Cllrs Brookes, Gamble and Lester and the Deputy Clerk. One resident was also present.

The resident is a voluntary car driver for the Health Centre and this scheme is starting again on 9th January. He picks up patients in The Grove but there is no where to park outside their properties due to other cars parking there. Cllr Lester informed the resident that this was a policing issue and it should be reported to 101 but the Council would pass his concerns on.

He also mentioned two external chimneys on Clover Road which burn wood but he believed this to be a smoke free zone. Cllr Lester informed him that the Council would notify SKDC on his behalf. He was also concerned about the staircase to the flats at the back of the Iron Horse Ranch. The handrail was a scaffolding plank and there was yellow netting flapping around. The members said they would report this to SKDC.

It was proposed by Cllr Lester seconded by Cllr Shelton and **RESOLVED** unanimously to accept that the minutes could be signed as a true and accurate record of the meeting. The minutes were signed accordingly

5. Clerks report on matters arising from last meeting

The Deputy Clerk had issued members with updates from the last meeting:

- The Deputy Clerk had emailed Jonathan Short for an update on the external painting of 116-122 Church Street but was still waiting a reply
- The press release by New River Retail for the parking scheme at the Co-op car park was issued on 8/12/16. The short stay parking would only be controlled between 6am and 6pm and there would be no overnight restrictions

For members to agree the budgets and to discuss any additional costs including the hiring of a pressure washer and legal costs for the allotments It was proposed by Cllr Gamble, seconded by Cllr Lester and RESOLVED unanimously to discuss agenda item 17 alongside this agenda item.

The Deputy Clerk went through the proposed precept explaining the reasons for the value of each item. Cllr Lester asked if members could agree this precept excluding the grass cutting costs since due to the public consultation not concluding until 9th January, this would be discussed at Council on 11th January. Cllr Shelton suggested that the Deputy Clerk enquires with Deeping St James Parish Council as to how often they were considering having the verges cut and the results of the consultation for their area. It was proposed by Cllr Lester to approve the planning and highways precept with the exclusion of the grass cutting costs and if it is agreed at Council on 11th January to cut the verges, then these costs could be included. This was seconded by Cllr Brookes and **RESOLVED** unanimously

9. For members to discuss the request from the Neighbourhood Plan team to have access to Parish Online

It was proposed by Cllr Lester, seconded by Cllr Gamble and **RESOLVED** unanimously to allow access to Parish Online but for Neighbourhood Plan use only
