#### 57. Clerk's Report and update on work of parkkeepers

#### John Eve field

- The Glebe field was used for a car boot sale on Sunday 13<sup>th</sup> March (this was cancelled due to the weather)
- NKDC Arboriculturist has examined trees
- Playground repairs have been carried out
- 10 tonnes of chippings received and logs for use by paddock volunteers

#### **Town centre**

#### Clerk's report

• Research has been carried out into an apprentice Horticulturist.

This is normally a fixed term contract, typically lasting for 12 months to 2 years. If the Employee is registered with an accredited training provider (College), and is pursuing stated learning outcomes, they will be paid the NMW rate of £4.81 per hour if they are under 19 or in the first year of their training.

They will be contracted to you, and are your Employee, although the training provider does have a lot of input into their conditions of work and what they can do. For example, they may want to do risk assessments before placing the worker starts, and also have regular access to conduct training reviews and meetings.

Generally, the hours are limited to something between 30 and 40. You cannot do less, as they need to be able to achieve their training outcomes, or more, for health and safety reasons.

The Clerk has not been able to find a suitable College course to back up the hands-on learning. The Clerk will telephone Stamford and Peterborough Colleges to find out more information

SKDC will provide a list of costs to enable the council to fully consider the transfer and budget implications which will be discussed at the next Full Council meeting.
