The invoice has been submitted to LCC for their contribution towards the Parish Agreement Scheme for Highway grass cutting for 2023/24. Going forward the agreement will now continue on a rolling annual basis but may be terminated by either party giving no less than two months written notice expiring at any time.	The Committee agreed that LCC's new process was a positive way forward. The Chair requested that the Clerks liaise with Deeping St James to see if they are happy with the new agreement process. The Committee requested that this is diarised 2-3 months before the renewal to allow the two months written notice period should the two council's wish to cancel the agreement in the future.
Bus shelter cleaning - the 6 months of cleaning has come to an end, Committee to consider if they wish to continue for another 6 months. The cost has been budgeted for in the precept.	The Committee agreed to continue for a further 6 months and acknowledged that the bus shelters were looking clean and tidy.

New covered Bus Shelter, outside the former Towngate Inn - the Deputy Clerk asked the committee if they wished to include a casing for the bus timetable and the council's logo. The Committee agreed that the existing casing located on the existing bus-stop pole was sufficient and that the logo would not be suitable. The Committee agreed that a label/plaque stating Market Deeping Town Council should be placed on the shelter with a view of placing a label/plaque on the existing shelters in the future.
